App Store if you're an iPhone


user, or Play Store on Android.

# Allow push notifications

When you've downloaded the app, you'll be prompted to allow push notifications, which we strongly recommend. This will make sure you remain in the loop about upcoming network events - including real-time updates to agendas, speaking slots and venue information - and on top of your direct messages.

If you did not initially allow notifications upon download, but now wish to, you'll be able to turn them on by heading to your device settings for the app.

## Log In


To access secure areas of the app - for example, community discussions and our resource library - you will first need to log in to your Multilaw account.

#### Here's how:


In the 'Home' section, tap on the profile icon in the top left hand corner

You can interact with each post on the feed in a number of different ways, such as liking, sharing, commenting, adding to your calendar and more.

Across the bottom of the Home screen, you'll notice a navigation bar, featuring a number of different icons. Tapping on each of these icons will take you to each of the following sections...





#### Information

Access event policies, add the event to your calendar, or share with colleagues via your preferred channels.




#### Connect

#### Speakers

Access Speaker profiles here, where you will also be able to add their session to your personal agenda list.



#### Selected Charity

If selected, here we will provide information about the charity that we have chosen to support at the event. You will have the opportunity to donate directly here.



#### Alerts

This will display any notifications or alerts sent from the Global Office regarding the event.



#### Companions

From here, see the itinerary where registered companions are welcome to join us (if applicable).






## **Address Book**

Either search for a name directly via the magnifying glass or at the top of the screen, or fill in the details of your chosen lawyer or firm via the filter, tap 'Apply', and then scroll through a list of results. Once you've found your desired firm or lawyer, you'll find a biography, contact details and the ability to message them privately.

#### Sending an Enquiry

When looking at a firm, you'll also see a 'Refer' button in the top right. Clicking this will prepopulate an email for you to send an enquiry to to the selected firm's contact partners. It'll also add your own firm's contact partners to the email – meaning the relevant personnel in both firms stay in the loop when sending enquiries to other firms within the Multilaw network.

This functionality is only for sending initial referral enquiries, and is not associated with reporting referrals. For reporting referrals, please continue to use the Multilaw Referral Reporting System.



## **Communities**


Scrolling through the Communities section will provide you with all ongoing discussions happening within your network groups.

You'll have the opportunity to engage with or comment on these discussions, as well as further access to individuals within these groups, and the ability to contact them via private messaging. Tap on the Group you wish to explore and find all relevant information and participants listed under 'Details'. Tap across to 'Discussions' along the top bar to reveal the latest group posts.


You'll only see Communities in the app that you're already a member of. To edit your group memberships, please head to your account page on the Multilaw website.

#### ■ News


This will take you to a scrollable feed of the latest network updates. Use the 'search', 'sort by' or 'filter' function at the top to help target your search.
